

## State of North Carolina

Surry County

On the 13<sup>th</sup> day of August 1832 personally appears in open court before William C. Martin, R H Parks and Thomas Williams, in the court of Pleas and Quarter Sessions, non selling Bartholomew Marion, a resident of this (Surry) County in the State of North Carolina after seventy seven years, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7, 1832, He was born in Albemarle county in Virginia and at four years old was brought by his parents to Granville County in North Carolina from thence in his youth he was removed to Bute County and thence when he was about eleven years old, he came with them to Surry. Where he has lived ever since with the exception of one year when he was in the state of Ohio.

The first tour of duty he performed was as a drafted solider, from Surry County under Captain James Shepperd, Colonel Lock was marched from Surry to Savanna River where they lay near Gen'l Lincoln's Camp, The Battle of Bryan Creek took place while he was with the army but he was not in it, he being with Gen'l Rutherford. He was then discharged but not in writing. He was five months engaged as a soldier in this tour. The next tour of duty (page 4) he performed was a volunteer in the Horse under Captain Dyer, Colonel Armstrong's Regiment and was marched to Hillsboro where he was present at an attack upon a British picket, having engaged in this tour six weeks. I was discharged but without writing. ~ Another tour he served under the same Captain Dyer, a volunteer after the Battle of Guilford in pursuit of Bryant, a commander of the Tories went across the forks of the Yadkin by Salisbury and round by the Moravian towns. He was in this tour two months. He was at another time, a volunteer two weeks guarding the prisoners taken at Kings Mountain at the Moravian Town. Colonel Armstrong was there but whether in command or not he knows not. He served in all about 9 months, as near as he can recollect. He has no record of his age and never had a written discharge. He's pretty generally known in his present neighborhood to Joseph Williams and others.

I hereby relinquish every claim whatever to a pension or annually except the present and declares that his name is not on the pension roll of the agency of any state.

his Bartholomew X Marion mark Mr. David Bray and Edward Smith do solemnly swear that we were acquainted with Bartholomew Marion in the revolutionary war, who know that he went as a volunteer with Captain Dyer in Col. Armstrong's regiment and were with him at the attack upon the Pickett Guard of the British at Hillsboro.

We, Jesse Briggs, a preacher in Methodist church residing in the county of Surry and Joseph Williams residing in the same county hereby certify that we are well acquainted with Bartholomew Marion, who has subscribed and sworn to the above declaration that we believe him to be seventy seven years of age, that he is reputed and believed in the neighborhood he resides to have been a soldier of the Revolution and that we concur in that opinion.

And the said court do hereby declared their opinion after the investigation of the matter and after putting the interrogations required by the War department that the above mentioned applicant was a revolutionary Soldier and served as he states and the court further (page 6) certifies that it appears to them that Jesse Briggs, who has signed the preceding certificate is a clergyman, resident in this county and that Joseph Williams who has also signed the same is a resident in this county and is a credible person and that their statement is entitled to credit
